In some cases, some of the dividends on your holdings may arrive to your account with your current provider after the transfer has taken place. This occurs when the record date for the dividend payment is before the transfer to PSIL and the payment date is after the transfer date. If you have any securities held in certificate/paper format that you wish to transfer into your account you will need to send us the certificates. We will review the certificates and then forward you the relevant forms to enable their transfer to your account at PSIL.
